

Instructions for ACL 2019 Proceedings

Anonymous ACL submission

Abstract

This document contains the instructions for preparing a camera-ready manuscript for the proceedings of ACL 2019. The document itself conforms to its own specifications, and is therefore an example of what your manuscript should look like. These instructions should be used for both papers submitted for review and for final versions of accepted papers. Authors are asked to conform to all the directions reported in this document.

1 Credits

Those versions were written by several people, including John Chen, Henry S. Thompson and Donald Walker. Additional elements were taken from the formatting instructions of the *International Joint Conference on Artificial Intelligence* and the *Conference on Computer Vision and Pattern Recognition*.

2 Introduction

The following instructions are directed to authors of papers submitted to ACL 2019 or accepted for publication in its proceedings. All authors are required to adhere to these specifications. Authors are required to provide a Portable Document Format (PDF) version of their papers. **The proceedings are designed for printing on A4 paper.**

All MSWord formatting for ACL 2019 is made available in the MSWord Styles in this template. In newer versions of MSWord, click Home, then expand the Styles tile by clicking the diagonal arrow on the lower left corner. This should open all styles in the template for you to apply to your document as needed. Otherwise, you may expose the Styles following the instructions provided at: <http://blogs.technet.com/b/hub/archive/2010/11/22/view-and-edit-styles-quickly-in-word-2010.aspx>.

3 General Instructions

Manuscripts must be in two-column format. Exceptions to the two-column format include the title, authors' names and complete addresses, which must be centered at the top of the first page, and any full-width figures or tables (see the guidelines in Subsection 3.6). Lines should be justified, with even spacing between margins (Ctrl+J). Single-spaced lines are permitted, but **authors are encouraged to use Paragraph spacing at Multiple, 1.05pt, with Font character spacing condensed with kerning of 0.1pt, and Margins at 0.98in**, for consistency with A4 paper and documents formatted with LaTeX. Go to Format, Document, Page Setup, and make sure A4 is selected. The manuscript should be printed single-sided and its length should not exceed the maximum page limit described in Section 5.

Pages have a ruler, header and footer for initial submission, with header at 0.3 in from top and footer at 0.4 in from bottom. When you first create your submission on softconf, please fill in your submitted paper ID where *** appears in the *** at the header at the top. If the paper is accepted, remove the header, footer (page numbers), and the ruler for the final version (camera-ready). **Do not number the pages in the camera-ready version.**

The review process is double-blind, so do not include any author information (names, addresses) when submitting a paper for review. However, you should maintain space for names and addresses so that they will fit in the final (accepted) version. The ACL 2019 MS Word style contains a 2.5 in table beneath the title for this purpose.

3.1 The Ruler

The ACL 2019 style defines a printed ruler that should be present in the version submitted for review. The ruler is provided in order that reviewers may comment on particular lines in the paper without circumlocution. If you are preparing a document without the provided style files, please arrange for an equivalent ruler to appear on the final output pages. The presence or absence of the ruler should not change the appearance of any other content on the page. The camera-ready copy should not contain a ruler.

In this Word template, you can add the ruler to each individual page by copying it from another page. The Ruler consists of separate left-hand rulers and right-hand rulers. Each ruler is a text box, sized 10 in x 0.45 in, flushed with the sides of the page, with a table containing numbers. The table has no borders, and the edges are pushed to the edges of the textbox. The left part of the ruler is justified left, left indent 0.1 in/right indent 0 in, and saved in the “ACL Ruler Left” style; and the right-hand ruler, justified right had left indent 0 in/right indent 0.1 in, saved in the “ACL Ruler Right” style. Number text is in Arial, and spacing between each line is Multiple, 1.05 in, with 4.5 pt below each line. After pasting a new ruler onto a page, highlight the ruler text and press **F9** to update the numbers. **Align** the text box **Middle**, and **Center**, and then **Arrange Behind Text**.

Reviewers: Note that the ruler measurements do not align well with lines in the paper — this turns out to be very difficult to do well when the paper contains many figures and equations, and, when

done, looks ugly. Just use fractional references (e.g., this paragraph ends at mark 141.5).

3.2 Electronically-available Resources

ACL provides this description in LATEX2e (`acl2019.tex`) and PDF format (`acl2019.pdf`), along with the LATEX2e style file used to format it (`acl2019.sty`) and an ACL bibliography style (`acl2019.bst`) and example bibliography (`acl2019.bib`). These files are all available at <http://naacl2019.org/downloads/acl2019-latex.zip>. A Microsoft Word template file (`acl2019-word.docx`) and example submission pdf (`acl2019-word.pdf`) is available online. We strongly recommend the use of these style files, which have been appropriately tailored for the ACL 2019 proceedings.

3.3 Format of Electronic Manuscript

For the production of the electronic manuscript, you must use Adobe's Portable Document Format (PDF). This format can be generated from postscript files: on Unix systems, you can use `ps2pdf` for this purpose; on Windows, you can use Adobe's Distiller, an online service such as <http://go4convert.com/>, or if you have `cygwin` installed, you can use `dvipdf` or `ps2pdf`.

Please make sure that your PDF file includes all the necessary formatting, hyperlinks, and fonts (especially tree diagrams, symbols, and fonts with Asian characters). When you print or create the PDF file, there is usually an option in your printer setup to include none, all, or just non-standard fonts. Please make sure that you select the option of including ALL the fonts. **Before sending it, test your PDF by printing it from a computer different from the one where it was created.** Moreover, some word processors may generate very large PDF files, where each page is rendered as an image. Such images may reproduce poorly. In this case, try alternative ways to obtain the PDF. One way on some systems is to install a driver for a postscript printer, send your document to the printer specifying “Output to a file”, then convert the file to PDF.

It is of utmost importance to specify the **A4 format** (21 cm x 29.7 cm) when formatting the paper. Print-outs of the PDF file on A4 paper should be identical to the hardcopy version. If you cannot meet the above requirements about the production of your electronic submission, please

contact the publication chairs above as soon as possible.

3.4 Layout

Format manuscripts two columns to a page, in the manner these instructions are formatted. The exact dimensions for a page on A4 paper are:

- Left and right margins: 2.5 cm
- Top margin: 2.5 cm
- Bottom margin: 2.5 cm
- Column width: 7.7 cm
- Column height: 24.7 cm
- Gap between columns: 0.6 cm

Papers should not be submitted on any other paper size. If you cannot meet the above requirements about the production of your electronic submission, please contact the publication chairs above as soon as possible.

3.5 Fonts

For reasons of uniformity, Adobe's **Times Roman** font should be used. If Times Roman is not available, you may use the Times New Roman font, which is often provided by default and only slightly different.

3.6 The First Page

Center the title, author name(s) and affiliation(s) across both columns (or, in the case of initial submission, space for the names). Do not use footnotes for affiliations. Use the two-column format only when you begin the abstract.

Title: Place the title centered at the top of the first page, in a 15-point bold font. (For a complete guide to font sizes and styles, see Table 1.) Long titles should be typed on two lines without a blank line intervening. Approximately, put the title at 2.5 cm from the top of the page, followed by a blank line, then the author name(s), and the affiliation(s) on the following line. Do not use only initials for given names (middle initials are allowed). Do not format surnames in all capitals (e.g., use “Mitchell,” not “MITCHELL”). Do not use format title and section headings in all capitals as well, except for proper names (such as “BLEU”) that are conventionally in all capitals. The affiliation

should contain the author's complete address, and if possible, an electronic mail address. Start the body of the first page 7.5 cm from the top of the page.

The title, author names and addresses should be completely identical to those entered to the electronic paper submission website in order to maintain the consistency of author information

among all publications of the conference. If they are different, the publication chairs may resolve the difference without consulting with you; so it is in your own interest to double-check that the information is consistent.

Abstract: Type the abstract at the beginning of the first column. The width of the abstract text should be smaller than the width of the columns for the text in the body of the paper by about 0.6cm on each side. Center the word **Abstract** in a 12 point bold font above the body of the abstract. The abstract should be a concise summary of the general thesis and conclusions of the paper. It should be no longer than 200 words. The abstract text should be in 10 point font.

Text: Begin typing the main body of the text immediately after the abstract, observing the two-column format as shown in the present document. Use 11 points for text. Indent when starting a new paragraph, about 0.16 in. This is accomplished with Right click, Styles, “ACL First Line”.

3.7 Sections

Headings: Type and label section and subsection headings in the style shown on the present document. Use numbered sections (Arabic numerals) in order to facilitate cross references. Number subsections with the section number and the subsection number separated by a dot, in Arabic numerals. In bold, use 11 points for subsection

300 headings, 12 points for section headings. Do not
301 number subsections.

302 **Citations:** Citations within the text appear in
303 parentheses as (Gusfield, 1997) or, if the author's
304 name appears in the text itself, as Gusfield (1997).
305 Collapse multiple citations as in (Gusfield, 1997;
306 Aho and Ullman, 1972). Append lowercase letters
307 to the year in cases of ambiguities. Treat double
308 authors as in (Aho and Ullman, 1972), but write as
309 in (Chandra et al., 1981) when more than two
310 authors are involved. Also refrain from using full
311 citations as sentence constituents.

312 We suggest that instead of

313 “(Gusfield, 1997) showed that ...”

314 you use

315 “Gusfield (1997) showed that ...”

320 **Hyperlinks:** Within-document and external
321 hyperlinks are indicated with Dark Blue text, Color
322 Hex #000099. In order to create hyperlinks
323 between citations and references, as you insert each
324 full reference in the References section, highlight
325 it and then select Insert, Bookmark. Link back to
326 the reference from its citations in the text by
327 highlight the citation, right clicking, and selecting
328 Insert, Cross-Reference, then selecting the
329 Bookmark you’ve saved. Highlight the citation
330 again to give make it dark blue (included in this
331 theme), if it is not automatically applied. If there
332 are problems saving the hyperlinks when you
333 convert the document to PDF, use an online
334 converter such as <http://go4convert.com>.

335 **Digital Object Identifiers:** As part of our work
336 to make ACL materials more widely used and cited
337 outside of our discipline, ACL has registered as a
338 CrossRef member, as a registrant of Digital Object
339 Identifiers (DOIs), the standard for registering
340 permanent URNs for referencing scholarly
341 materials. As of 2017, we are requiring all camera-
342 ready references to contain the appropriate DOIs
343 (or as a second resort, the hyperlinked ACL
344 Anthology Identifier) to all cited works. Thus,
345 please ensure that you use References that contain
346 DOI or URLs for any of the ACL materials that you
347 reference. Appropriate records should be found for
348 most materials in the current ACL Anthology at
349 <http://aclanthology.info/>.

350 As examples, we cite (Goodman et al., 2016) to
351 show you how papers with a DOI will appear in the
352 bibliography. We cite (Harper, 2014) to show how
353 papers without a DOI but with an ACL Anthology
354 Identifier will appear in the references.

355 As reviewing will be double-blind, the submit-
356 ted version of the papers should not include the
357 authors’ names and affiliations. Furthermore, self-
358 references that reveal the author’s identity, e.g.,

359 “We previously showed (Gusfield, 1997) ...”

360 should be avoided. Instead, use citations such as

361 “Gusfield (1997) previously showed ... ”

365 **Please do not use anonymous citations** and do
366 not include acknowledgements when submitting
367 your papers. Papers that do not conform to these
368 requirements may be rejected without review.

369 **References:** Gather the full set of references
370 together under the heading **References**; place the
371 section before any Appendices. Arrange the
372 references alphabetically by first author, rather
373 than by order of occurrence in the text. Provide as
374 complete a reference as possible, using a consistent
375 format, such as the one for *Computational*
376 *Linguistics* or the one in the *Publication Manual of*
377 *the American Psychological Association*
378 (American Psychological Association, 1983). Use
379 of full names for authors rather than initials is
380 preferred. A list of abbreviations for common
381 computer science journals can be found in the
382 Association for Computing Machinery (1983)
383 *Computing Reviews*.

384 The bibliography style described here roughly
385 fits the American Psychological Association
386 format, allowing regular citations, short citations
387 and multiple citations as described above.

388 Submissions should accurately reference prior
389 and related work, including code and data. If a
390 piece of prior work appeared in multiple venues,
391 the version that appeared in a refereed, archival
392 venue should be referenced. If multiple versions
393 of a piece of prior work exist, the one used by the
394 authors should be referenced.

395 **Appendices:** Appendices, if any, directly
396 follow the text and the references. Letter them in
397 sequence and provide an informative title:
398 **Appendix A. Title of Appendix.**




Figure 1: Figure caption.

3.8 Footnotes

Footnotes: Put footnotes at the bottom of the page and use 9 point font. They may be numbered or referred to by asterisks or other symbols.¹ Footnotes should be separated from the text by a line.²

3.9 Figures and Tables

Creating: To create a new Figure or Table, insert a Text Box where you want it to appear (generally, centered at the top of a column close to where it is referred to) and then fill it in with the Figure (or Table). Highlight and right click to add Caption, with the ACL Caption style, which places 10 pt below and above the caption.

Placement: Place figures and tables in the paper near where they are first discussed, as close as possible to the top of their respective column. Wide figures and tables may run across both columns and should be placed at the top of a page.

In MSWord, authors can place a Figure (*e.g.*, a graphic and its caption) inside the rows of a 2 x 1 table (2 rows and 1 column) with invisible borders. Specify table positioning by right-clicking its handle in the upper left corner. Place the image in the center of the first row, and the caption in the center of the second row.

Captions: Provide a caption for every table and figure; number each one sequentially in the form: "Figure 1: Figure caption.", "Table 1: Table caption." Type the captions of the figures and tables below the body, using 10 point text. Captions should be placed below illustrations. Captions that are one line are centered. Captions longer than one line are left-aligned.

¹ This is how a footnote should appear.

² Note the line separating the footnotes from the text.

Numbering: To update numbering, highlight all the relevant text (*e.g.*, **Ctrl-A + F9**). This will update all the numbering applicable to tables, figures, equations, and headings.

Cross-referencing: To add a cross reference to a figure or table:

- Place the mouse pointer at the location where you wish to add the cross-reference.
- Click on the **Insert** menu, (then click **Reference**), and then **Cross-reference** in the **Links** panel.
- In the **Cross-reference** dialog box, click the caption to which you are building the text reference.
- For a figure, under **Reference Type**, click **Figure**.
- Under Insert Reference To, click Only Label and Number, then click OK.
- Once the reference is in place, apply the 'Normal' font style (size 11, no bold face).
- This is an example reference to Figure 1.

3.10 Equations

An example equation is shown below:

$$A = \pi r^2 \quad (1)$$

To add new equations, authors are encouraged to copy this existing equation line, and then replace with the new equation. The numbering and alignment of equation line elements is automatic. To update equation numbering, press **Ctrl-A + F9**. Note: this will only update the number to the right of the equation; to update numbering within the text you must create a cross-reference.

Cross-referencing: To create a cross-reference for an equation:

- Create a bookmark for it.
- Select the number to the right of the equation. Go to **Insert, Bookmark** (in the **Links** panel), and then create a name for your equation. Press **Add** to create the bookmark.
- To refer back, place the mouse pointer at the location where you wish to add the cross reference.

- Go to **Insert, Cross-reference** (in the **Links** panel). In the dialogue box, select **Bookmark** and **Bookmark Text** from each dropdown list. Uncheck **Insert as Hyperlink**, then click **OK**.
- This will make it such that whenever a new equation is added, the references to the equation will be updated when **Ctrl-A + F9** is pressed.
- This an example cross-reference to Equation (1).

3.11 Accessibility

In an effort to accommodate people who are color-blind (as well as those printing to paper), grayscale readability for all accepted papers is encouraged. Color is not forbidden, but authors should ensure that tables and figures do not rely solely on color to convey critical distinctions. A simple criterion: All curves and points in your figures should be clearly distinguishable without color.

3.12 From Submitted to Camera-Ready

To remove submission formatting for the camera-ready document, delete the header and footer on the first page (double clicking in the area, then delete the text). This will remove them from the rest of the document. To remove the ruler, highlight the lists of numbers and delete.

4 Translation of non-English Terms

It is also advised to supplement non-English characters and terms with appropriate transliterations and/or translations since not all readers understand all such characters and terms. Inline transliteration or translation can be represented in the order of:

original-form
transliteration
“translation”.

5 Length of Submission

The ACL 2019 main conference accepts submissions of long papers and short papers. Long papers may consist of up to eight (8) pages of content, plus unlimited pages for references. Upon acceptance, final versions of long papers will be given one additional page — up to nine (9) pages with unlimited pages for references — so that

reviewers’ comments can be taken into account. Short papers may consist of up to four (4) pages of content, plus unlimited pages for references. Upon acceptance, short papers will be given five (5) pages in the proceedings and unlimited pages for references. For both long and short papers, all figures and tables that are part of the main text must be accommodated within these page limits, observing the formatting instructions given in the present document. Papers that do not conform to the specified length and formatting requirements are subject to be rejected without review.

ACL 2019 does encourage the submission of additional material that is relevant to the reviewers but not an integral part of the paper. There are two such types of material: appendices, which can be read, and non-readable supplementary materials, often data or code. Do not include this additional material in the same document as your main paper. Additional material must be submitted as one or more separate files, and must adhere to the same anonymity guidelines as the main paper. The paper must be self-contained: it is optional for reviewers to look at the supplementary material. Papers should not refer, for further detail, to documents, code or data resources that are not available to the reviewers. Refer to Appendix A and Appendix B and for further information.

Workshop chairs may have different rules for allowed length and whether supplemental material is welcome. As always, the corresponding call for papers is the authoritative source.

6 Multiple Submission Policy

Papers that have been or will be submitted to other meetings or publications must indicate this at submission time. Authors of papers accepted for presentation at ACL 2019 must notify the program chairs by the camera-ready deadline as to whether the paper will be presented. All accepted papers must be presented at the conference to appear in the proceedings. We will not accept for publication or presentation papers that overlap significantly in content or results with papers that will be (or have been) published elsewhere.

Preprint servers such as arXiv.org and ACL-related workshops that do not have published proceedings in the ACL Anthology are not considered archival for purposes of submission. Authors must state in the online submission form the name of the workshop or preprint server and title of the non-archival version. The submitted

600 version should be suitably anonymized and not
 601 contain references to the prior non-archival
 602 version. Reviewers will be told: “The author(s)
 603 have notified us that there exists a non-archival
 604 previous version of this paper with significantly
 605 overlapping text. We have approved submission
 606 under these circumstances, but to preserve the
 607 spirit of blind review, the current submission does
 608 not reference the non-archival version.”
 609 Reviewers are free to do what they like with this
 610 information.

611 Authors submitting more than one paper to
 612 NAACL must ensure that submissions do not
 613 overlap significantly (> 25%) with each other in
 614 content or results. Authors should not submit short
 615 and long versions of papers with substantial
 616 overlap in their original contributions.

618 This Microsoft Word file was updated in 2016 with
 619 STREAM Tools, designed for creating well-
 620 formatted reports and papers with Microsoft Word
 621 (Mamishv, 2010; Mamishv, 2013).

623 Acknowledgments

624 The acknowledgements should go immediately
 625 before the references. Do not number the
 626 acknowledgments section. Do not include this
 627 section when submitting your paper for review.

617 A Appendices

618 Appendices are material that can be read, and
 619 include lemmas, formulas, proofs and tables that
 620 are not critical to the reading and understanding of
 621 the paper. Appendices should be **uploaded as**
 622 **supplementary material** when submitting the
 623 paper for review. Upon acceptance, the appendices
 624 come after the references, as shown here.

625 B Supplementary Material

626 Submissions may include non-readable
 627 supplementary material used in the work and
 628 described in the paper. Any accompanying
 629 software and/or data should include licenses and
 630 documentation of research review as appropriate.
 631 Supplementary material may report preprocessing
 632 decisions, model parameters, and other details
 633 necessary for the replication of the experiments
 634 reported in the paper. Seemingly small
 635 preprocessing decisions can sometimes make a
 636 large difference in performance, so it is crucial to
 637 record such decisions to precisely characterize
 638 state-of-the-art methods.

639 Nonetheless, supplementary material should be
 640 supplementary (rather than central) to the paper.
 641 **Submissions that misuse the supplementary**
 642 **material may be rejected without review.**
 643 Supplementary material may include explanations
 644 or details of proofs or derivations that do not fit into
 645 the paper, lists of features or feature templates,
 646 sample inputs and outputs for a system, pseudo-
 647 code or source code, and data. (Source code and
 648 data should be separate uploads, rather than part of
 649 the paper).

The paper should not rely on the supplementary material: while the paper may refer to and cite the supplementary material and the supplementary material will be available to the reviewers, they will not be asked to review the supplementary material.
